We are excited to share with you a draft of our Year 6 Policies, Regulations, and Financial Review (PRFR) report for our accreditation efforts.

Background

Last November we shared an [accreditation update](#) that provided an overview of our responsibilities and the benefits of being accredited by the Northwest Commission on Colleges and Universities (NWCCU).

From the contributions of many individuals our initial draft of the PRFR was produced in early April. For the first draft review, councils, committees, and teams were invited to review portions of the PRFR that closely aligned with their scope of work.

An Invitation to You

For our second draft review of the PRFR we are inviting you to examine the document as a whole and share feedback to strengthen our story.

A form has been created for you to provide anonymous feedback on the PRFR for any or all sections. This form will remain open until June 21st at 5 pm. Following the Pierce College Community draft review our Marketing and Communications Department will edit for grammar, voice, and format. The final review of the report will be by the Board of Trustees before the report is submitted to the NWCCU in early September.
